Sub: Intimation of allotment of Preference Shares to Mr. Devesh Singh Sahney under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform you that, the Board of Directors of the Company vide its resolution passed in board meeting dated 25th May, 2023, approved the allotment of 75,00,000 (Seventy Five Lakhs Only) Cumulative, Redeemable, Non-Convertible Preference Shares ("CRPS") of a face value of INR. 10/- each amounting to INR 7,50,00,000 (Rupees Seven Crores Fifty Lakhs Only) to Mr. Devesh Singh Sahney, Chairman & Managing Director of the Company on private placement basis. The said allotment is made pursuant to Section 62(3) of the Companies Act, 2013 and as per the terms and conditions approved by the shareholders for conversion of outstanding loan into preference shares.

The salient features of the allotment are as follows:

- The holders of CRPS shall be paid dividend on a cumulative basis at the rate as recommended by the Board and declared by the shareholders of the Company. Presently, the preference dividend be paid annually at 2% p.a. post tax expenses;
- The CRPS shall not be convertible into equity shares of the Company;
- The CRPS shall be redeemed within a maximum period of 10 years as determined by the Board of Directors;
- The CRPS shall not be listed on any stock exchanges.
