Sub:- Request Letter for Reclassification from "Promoter & Promoter Group" Category to "Public Category" under Regulation 31A of the SEBI (Listing Obligations and Disclosure requirements) Regulations, 2015

A. Background and Current status

With reference to the captioned subject, I Anjana Milind Thakker, representing 61,262 (Sixty One Thousand Two Hundred and Sixty Two) Equity Shares constituting 0.21% of the Total Equity Share Capital of the Company and currently classified by the Company under "Promoter & Promoter Group" Category in the Shareholding Pattern filed with the Stock Exchanges namely BSE Limited and the NSE Limited (collectively, the "Stock Exchanges") where the shares of the Company are presently listed.

Additionally, I wish to clarify that I have not served in any capacity on the Board of the Company. I have no involvement in the business or management of the Company apart from being a shareholder. I do not participate in the day-to-day operations or decision making processes of the Company. It's important to note that I do not possess any authority to appoint directors or exert control over Company's management or policy decisions, except through voting rights from my shareholding. Furthermore, my actions have no influence on the Company's management or decision making processes.

B. <u>Undertaking</u>

In accordance with the provisions of Regulation 31A of SEBI (Listing Obligations and disclosures requirements) Regulations 2015,

I. I hereby undertake and certify as follows:

- a) I along with persons related to me together: do not hold more than ten percent of the total voting rights in the company.
- I do not exercise control over the affairs of the company, directly or indirectly.
- c) I do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements.
- d) I do not represent on the board of directors (including not having a nominee director) of the Company
- e) I do not act as a key managerial person of the Company
- f) I am not 'wilful defaulter(s)' as per the Reserve Bank of India Guidelines are not fugitive economic offender
- II. There is no pending regulatory action against me.
- III. I shall continue to comply with the conditions mentioned at subclauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 at all times from the date of re-classification, failing which, I shall be reclassified as promoter/person belonging to the promoter group of the company.
- IV. I shall comply with the conditions mentioned in the of sub-clauses (iv) and (v) of clause (b) of Regulation 31A(3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 for a period of not less than three years from the date of reclassification, failing which, I shall be reclassified as promoter/person belonging to promoter group of the company.

C. REQUEST FOR RE-CLASSIFICATION

On the basis of above reasons and confirmations provided in this letter, I hereby seek to reclassify my shareholding from "Promoter & Promoter Group Category" to "Public Category".

I request you to acknowledge the receipt of this letter and take necessary action in this regard.
